



Serious Illness

If you or someone presently and normally living in your home is seriously ill, please have your physician call us at 203-562-4020. Your doctor must send us a letter telling us about the nature and length of the illness within a week after they call us. You will be required to make an equitable arrangement to pay your past due bills and to pay on a current basis all future bills during the duration of the illness.
