1. Approval of Meeting Minutes

S. Vitko presented minutes from April 26, 2023, meeting. H. Petroskey moved to approve the meeting minutes, and J. Cottell seconded the motion.

2. 2023 Season Updates

S. Vitko opened by mentioning the 2023 season was a success. 7,000 households participated in the HazWaste program this year. There were six satellite locations held, with two starting prior to season. S. Vitko stated several safety improvements were made. Some of the improvements include re-painting lines that direct cars, the initiation of flagging, as well as more signage. S. Vitko discussed the annual audit, mentioning it went well. Another improvement includes the integration of Smartsheet to streamline the registration procedure process. S. Vitko mentioned the importance of pre-registering residents, and to put that in advertisements going forward.

3. Program Management Update

S. Vitko announced new HazWaste program management update and made introductions. 4. Advertisements & Outreach

S. Vitko explained that the Regional Water Authority (RWA) is going to be doing outreach and advertising for 90 Sargent Dr. location. RWA will provide municipalities with the advertisements, but towns are responsible for posting on their social media platforms and coordinating outreach methods.

5. Municipal Helpers

S. Vitko stated we will be creating a spreadsheet for municipal helpers. It is recommended two volunteers be sent moving forward. Municipal helpers help reduce cost of program. He mentioned we will give municipalities a month heads up in order to recruit helpers.

6. Invoice Update

S. Vitko apologized for last invoice cycle. He noted that due to a brand-new team getting acclimated to the program, there were delays. He mentioned the team will aim to get invoices out around mid to late February.

7. Membership Resolutions

S. Vitko mentioned membership resolutions are being reviewed. He emphasized that municipalities that have yet to sign their resolutions do it as soon as possible.

8. Outstanding Payment

S. Vitko mentioned we are continuing to review payments and membership resolutions.

Comments and suggestions:

H. Petroskey asked about containers used to drop off oil, and the process of getting rid of them. S. Vitko explained Clean Harbors drains and cleans them. If it's a satellite collection, everything gets shipped out day of. If at 90 Sargent Dr. location, it gets shipped out weekly. H. Petroskey asked if dates for next year have been determined. S. Vitko said tentatively May 11- October 26, but can't confirm until Clean Harbors contract finalized. K. Watsey mentioned contract is under negotiation. Once dates are confirmed, we will release to towns.
