The regular meeting of the Consumer Affairs Committee ("CAC") of the Representative Policy Board ("RPB") of the South Central Connecticut Regional Water District ("RWA") took place on Monday, October 16, 2023, via remote access.

Mr. Mongillo called the meeting to order at 5:31 p.m. He reviewed the Safety Moment distributed to members.

Mr. Mongillo offered the opportunity for members of the public to comment. There were no members of the public present at the meeting.

Atty. Donofrio reported on the status of the New Haven property tampered meter dispute. He stated that the customer is cooperating with the RWA and the matter is on the path to resolution.

Atty. Donofrio also reported that he submitted additional testimony to the Department of Public Heath for interpretation and support of RWA's obligations under the Lead & Copper Rule.

Atty. Donofrio also noted that he attended the two public hearings last month for the disposition of Class III lands in North Branford and submitted his memo in support of the dispositions.
