## NOMINATING COMMITTEE

MAY 8, 2024
SPECIAL MEETING TRANSCRIPTION

## Charles:

I'll call the meeting of the Nominating Committee to order. Everyone has had an opportunity to review the Safety Moment so we will move onto the committee's order of business.

We are here to consider RPB officers for the upcoming year beginning on July $1^{\text {st }}$. According to the Bylaws, when officers are elected they can serve for three consecutive years, with the exception of the chairman, who gets an extra year. I've had some very general past conversations with Tim. He would have no problem being chair. Whether we wanted to make that transition now, I don't know how anybody feels about that. But there's no reason to do it now because everybody is in their first year. But it's something we could do and we could start the process of preparing for chairmanship [inaudible 00:05:41] three years at this point. Right?

That would give Tim three years to prepare for [inaudible 00:06:19]

He's the treasurer. He's an officer of the Executive Committee.

Mark:
I knew he was on the Executive Committee. So I don't see what's the difference whether you're vice chairman or secretary. You're on the Executive Committee and this is the first year for those officers.

I was just thinking of succession.

Mark:
I think it just should stay the way it is, but that's only my opinion.

Excuse me, Jennifer, I'm having trouble hearing people. Can you increase your volume?

I'm sorry. I was just saying ... Can you hear me now?

Mark:
Yes.

Okay. Well, I was just saying that we're talking about looking forward, about Jamie possibly getting in line as well. But I was just saying, she just retired. She's trying to get her children together and deal with her new knee. So maybe thinking of her a little ways down the road. Give them another year. That's how I feel about it.

## Greg:

Yes, I don't think there's any rush right now because they got three more years on. Bob has after this year, they got two more years, and Bob has three more years.

## Charles:

We'll just let [inaudible 00:08:24] with nobody else expressing any interest in the board, I don't even see any need to make any changes whatsoever.
