Page 11 at that. Rochelle: This one is actually, GHP Media has worked under a big exemption in the past, but we actually want to be able to negotiate with others because it might not be the preferred for everything that we're doing in space. Mario: It wasn't clear to me, it sounded like you just wanted to exclusively go to GHP Media, unless I read it wrong. Rochelle: We want to actually be able to work with others, as well, to negotiate. Additional media coverage may be used for commercial marketing, just as an example. Mario: So you want an exemption so that you can negotiate with various vendors to provide? Rochelle: Do you feel like the minutes satisfactorily cover that? Mario: If the minutes can reflect that, I'm okay with it. David: The minute taker heard that. You got that? Mario: In other words, if we can reflect that.

Larry:

But in the past we've said that about 70% of our employees are on site officially, we are allowing employees to work at home a hundred percent of the time if their job permits that. However, we among the management team have been talking about this for quite some time. When was the right time to change that policy? We've decided that effective, I think it's June 3rd, the first Monday in June, we're going to have the employees that are currently working remotely come back to work in the office, probably roughly three days a week. Subject to their division and manager's desires and taking into account people's personal situation that they have to, for some reason work at home, remotely. But we're going to make that official come the first Monday in June, and we'll open up the lobby as well. So we'll start having customers be able to visit the lobby and make payments and do whatever they need to do, do there.

I wanted to mention that to the RPB tonight as well. But we've been debating this for quite some time. There's a lot of research out there about team working at home is not as great as it was thought to be. Other articles are saying, well, it's still the same to do. A lot of employees are still asking for that option when they're considering coming to work here, when it makes sense. It's something that we'll have to

be somewhat flexible on, and it'll be subject to the division VPs, or department or division heads discretion on exactly what the schedule is. But it's roughly at least three days a week.

Suzanne:

And do we have the space for it?

Larry:

We do. It's tight. Yes, we can accommodate or just have some of those people work at home too. I mean, we can rotate that.

Suzanne:

Are you opening up yourself to a lot of favoritism? Difficulty getting along because it's going to be very subjective.

Liz:

I could answer that.

Larry:

Go ahead, Liz.

Liz:

Yes, so we did revise the policy and we are doing it consistently. It is department, division, and role. And the performance basis will be on, we're going to manage their performance, their communication levels and all that. We're not really, I don't think we're going to get in any trouble with any kind of favoritism because it is based upon the job and the need, customer facing versus not. We looked at all that criteria and made sure that we have outlined that to avoid any of that.

Suzanne:

You got 13 call people, you want to have seven at home and six that are going to have to come in.

Liz:

Nope. Because we have a strict schedule. What they're planning to do is a Tuesday, Wednesday, Thursday, and Dana and Prem came up with that schedule, just to avoid picking and choosing days. And a strict online... If your day's in office and you can't come in, you can't swap, you need to use your PTO time. That way it would avoid anybody coming in and making those schedules as is, which we're trying to change.

Larry:

I got to hand it to Liz. She's worked through all the difficult, working with each one of the division heads, to come up with this policy that we've rolled out. She's done a great job with that.

David:

Thank you Liz. I believe in getting people back in. I believe that the collaborates see each other, and chance meetings and chance discussions matter a lot. And I think we missed a lot.
