Minutes of the June 26, 2023 Meeting

The regular meeting of the Consumer Affairs Committee ("CAC") of the Representative Policy Board of the South Central Connecticut Regional Water District ("RPB") took place on Monday, June 26, 2023, via remote access.

Chairman Mongillo called the meeting to order at 5:30 p.m. He reviewed the Safety Moment distributed to members.

Chair Mongillo offered the opportunity for members of the public to comment. There were no members of the public present at the meeting.

Atty. Donofrio, Office of Consumer Affairs, provided a presentation of the Representative Policy Board's (RPB) Governance, FOIA, and Ethics practices, which included highlights of:

On motion made by Mr. Rescigno, and seconded by Ms. Campbell, the committee voted to approve the minutes of its May 15, 2023 meeting, as presented, with Mr. Smith abstaining.

Attorney Donofrio reported that he spent much of June reviewing the Authority's Applications for the Derby Wellfield Chemical Improvements Project and Target Two, as well as preparing for the public hearings. He also noted that he prepared the governance presentation that was given to the three statutory committees of the RPB Committee in June. Attorney Donofrio also reported on the status of his submission of a second piece of testimony to the Drinking Water State Revolving Fund related to the Lead and Copper rule and how the process will be addressed. He is still waiting for a response.

Atty. Donofrio reported no consumer complaints or escalations.

On motion made by Mr. Rescigno, seconded by Mr. Smith, and unanimously carried, the Committee approved the OCA's May 2023 billing for \$6,285.00.
