Okay, then we've got experienced hands here. And as you know, with the Bylaws, it's quite detailed in terms of the sequence of events and the obligation of the chairman of the RPB to call for a Nominating Committee, and to proceed with that process, which we should conclude before the term of the incumbent expires, which I believe would be at the end of this year, and the new term would begin on January 1 of 2025.

I know with that, if you've had a chance to review that in terms of the sequence of events ... And I just want to move on if I could in terms of, and it's quite detailed, the bylaws in terms of the composition of the Nominating Committee, et cetera. I know there's a deadline. I believe it's August 1. If any members of the RPB are interested in applying for the position, they are to do so I believe by that day. And the position, which is currently held by an incumbent ... Susan is, as I understand, seeking reappointment. Those five years have flown by and now she's indicated her interest. And I do know, among the materials, we do have her impressive resume so we have an opportunity to check that as well. And then we have, of course, the criteria for the appointment of the candidate.

And over time, we've [inaudible 00:06:13] and burnished and provided more concrete detail in terms of what we see collectively on the Representative Policy Board as the necessary wherewithal for an individual to serve as a member of the Authority, the Five Member Authority. It includes behavior and characteristics, includes education. I think the minimum is a bachelor's degree. We have those with graduate degrees, those with engineering degrees. We're quite blessed with the composition of the Five Member Authority. And then also, the interfacing and group dynamics that comes with that critical position in terms of work and organization and background.

I know we have to provide this for input at the September meeting of the Representative Policy Board so they can add to it or maybe provide some further editing of what we see as the criteria. Is there anything that anyone would like to add at this time? I do know we're going to await, and we're hoping it should be by mid-September that we have the input from both the CEO of management, as well as the chairman of the Five Member Authority. It's critical to have their input because I think with them, they'll

be able to inform us as to the actual clinical application of this criteria and the process of the Regional Water Authority. So is there anything that anyone would like to add at this juncture? And again, this is just our introductory meeting, but I don't want to proceed too fast or preempt any input from anyone at this stage.

I'm hoping that it would be before the next regular schedule meeting of the Representative Policy Board so that we would hear from them and be informed by their experience, or some recommendations they may see because of the changing landscape of water and the utility and the regulatory environment in Connecticut, maybe nationally as to what our needs are in terms of the Five Member Authority. So we'll have the opportunity for their input at the next meeting, and I'm hopeful that we could work out, maybe before we conclude tonight, to assist Jennifer in scheduling that.
Brian:
Are we looking for their input on both the criteria and on the candidacy of Susan, or are we really just looking for their input on one or the other? I mean, I would think we're hoping to get their input on both at that one meeting.

Is that correct?

Tom:

I'd be open to that, Brian, unless anyone has any objections. I think that for the most part, we certainly want the input from the chairman of the Five Member Authority and the interaction, and then also from the president, the CEO of the Regional Water Authority. So that would be both relative to the incumbent and also the needs, what they may see as particular needs that have to be addressed or fulfilled. Or maybe they really don't have anything more to add, but I'd like their input. And then we would submit the criteria, subject to any revisions or recommendations, that Leary would make or Dave Borowy would make to the members of the Representative Policy Board.

But my question is we're making a determination there about if there's any changes needed and what their opinion is about Susan Sack and what their feedback is. And then will we meet after that, have them step away and make a decision, or will we wait and then, on the 16th, meet again to make a decision? I read the Bylaws and I know the middle of September, there's all these deadlines and I don't have them in front of me. I apologize. Because I think they said the middle of September, but it had to be done before the end of December. There was an October deadline as well, so I've got them mixed up in my head. But are we making the nomination for the vote on the 26th?

No, I believe the 26th is just giving the criteria to the RPB so that the rest of the RPB can comment on the criteria if they need to change it. And then once the criteria are developed, then we can meet with the candidate and decide. And then after meeting with the candidate, we can decide. If so, then we can give that directly to the RPB. Or if we say, "No, we want to open it up," then we can open it up and interview other people.

Nominating Committee August 28, 2024 Tom: The busy part of this process is October. It's about the middle of October, as I recall. Jamie: Okay. Tom: We have to meet with Suzanne. I think that's essential, and I'd like that to be an in-person meeting ... Brian: Yes. Tom: If possible. And then beyond that, we'll make the decision whether to stay in-house and simply go with Suzanne, it would be our recommendation. Or based on what we learned from either the chairman or from the CEO, it'll be our collective decision whether there's a need or necessity to go out and they advertise it as an open position. But that's not until the third week of October, so there's a lot of time. Okay? Any questions? Jamie: You run an efficient meeting, Tom. Tom: It's wonderful working with you guys, really.
